METHODOLOGY

In the United States, the poll of 1059 respondents was fielded June 27-July 2 with a margin of error of +/- 3.1-4.3% depending on the sample size for each question. The poll was fielded by Knowledge Networks, using its nationwide panel, which is randomly selected from the entire adult population and subsequently provided internet access. In India, the nationwide poll of 1639 respondents was conducted June 19-25 using face-to-face interviews and was fielded by C-Voter with a margin of error of +/- 2.5%. In Germany, the nationwide poll of 1002 Respondents was conducted by telephone June 6-25 and was fielded by Ri*Questa GmbH. In Great Britain, the nationwide poll of 1004 respondents was conducted by telephone June 13-25 and was fielded by ICM Direct. In Poland, the nationwide poll of 1639 respondents was conducted June 9-13 using face-to-face interviews and was fielded by TNS-OBOP. The Polish, German and British polls all had a margin of error of +/- 3.2.
